# $Hong\,Kong\text{-}Country\,overview$

#### **Business visitor activities**

Visa waiver nationals are eligible to enter Hong Kong without obtaining a visa in advance, for a duration of between 7 days and 180 days depending on nationality. A full list of visa waiver countries is available on the Immigration Department of Hong Kong website.

#### Permitted activities as a business visitor include:

- Attending business meetings and conferences.
- Submitting tenders.
- Visiting exhibitions or trade fairs as a potential buyer.
- Speaking or presenting at one-off events (if the visit is for less than 7 days and the visitor is not paid to do so).

#### Main work permit types

All foreign nationals who wish to work in Hong Kong are required to obtain work authorisation. Below is a brief overview of the common categories of work permits available:

## Employment visa – General Employment Policy (GEP)

The GEP is the most common work permit category

for foreign nationals entering Hong Kong for work purposes.

#### Key eligibility requirements:

- The applicant must have relevant educational qualifications suitable for the position in Hong Kong.
- Genuine job vacancy and offer of employment in Hong Kong in a role relevant to the qualifications of the applicant.
- The minimum salary threshold must be met which is based on the standard market rate.
- The role cannot be filled by the local workforce.

#### **Duration of permit:**

 The GEP permit is generally granted for a duration of 2 years and can be extended twice for an additional 3 years.

#### Approximate processing times:

 1-2 months once the complete application has been submitted.

## Admission Scheme for Mainland Talents and Professionals (ASMTP)

The ASMTP is for residents of mainland China applying to come and work in Hong Kong.



#### Key eligibility requirements:

- Must be residents of mainland China and possess specialised skills, knowledge or experience of value that are not readily available in Hong Kong.
- The applicant must have relevant educational qualifications suitable for the position in Hong Kong.
- Genuine job vacancy and offer of employment in Hong Kong in a role relevant to the qualifications of the applicant.
- The minimum salary threshold must be met which is based on the standard market rate.
- The role cannot be filled by the local workforce.

#### **Duration of permit:**

 The ASMTP permit is generally granted for a duration of 2 years and can be extended twice for an additional 3 years.

#### Approximate processing time:

• 1-2 months once the complete application has been submitted.

#### Key documents for GEP/ASMTP permits:

- Application form from the employer and from the employee.
- Passport.
- Proof of academic qualifications and relevant work experience.
- CV
- Employment contract and references.
- Proof of companies' financial standing and background (business registration certificate, business plan, tax returns, company brochure).
