Background (1)



- Net migration figures published 23 November 2023
 - 672,000 in year ending June 2023 up from 300,000 -400,000 pre -pandemic
 - Increase due mainly to international students, health and care workers, Ukraine / Hong Kong
 (BNO) routes
 - Home Secretary's announcement on 4 December 2023
 - "Slash migration levels"
 - "Deter employers from over-relying on migration"
 - "Crack down on cut-price labour from overseas"
 - "Far more must be done to bring those numbers down so British workers are not undercut"
 - "Halt the drastic rise in our work visa routes and crack down on those who seek to take advantage of our hospitality"

Background (2)



- Policies to reduce net migration
 - Most students can no longer bring family members to UK: 1 January 2024
 - Immigration Health Surcharge increased: 6 February 2024
 - Care workers can no longer bring family members to UK: 11 March 2024
 - Skilled Worker visas salary thresholds increase: 4 April 2024
 - Family visas minimum income requirement increases: 11 April 2024
 - Graduate visa route − MAC review: 14 May 2024
- New rules published 14 March 2024



Skilled Worker visas

Key changes



General salary threshold

£38,700 per year (up from £26,200 per year)

Going rates

- Median full-time salary for occupation code (up from 25th percentile)
- 2023 ONS salary data (not 2021 data)
- SOC 2020 occupation codes (not SOC 2010)
- No discount for jobs on Immigration Salary List (20% discount abolished)

Key date: Thursday 4 April 2024



- Application submitted before 4 April
 - decided under current rules
- CoS assigned before 4 April and used in application submitted on or after 4 April
 - decided under current rules
- CoS assigned on or after 4 April
 - decided under new rules

Current rules: standard scenario (option A)



General salary threshold	£26,200 per year
Going rate	Going rate for occupation code (set at 25th percentile using 2021 salary data)
Minimum hourly rate	£10.75 per hour

Salary must meet all three requirements

New rules: first -time applicants v pre-4 April 2024 Skilled Worker visa holders



Separate requirements in the new rules for:

First-time applicants – people submitting their first Skilled Worker application

Pre-4 April 2024 Skilled Worker visa holders — people who already have a Skilled Worker visa granted under the pre-4 April rules



New rules: first-time applicants

First-time applicants: standard scenario (option A)



General salary threshold	£38,700 per year
Going rate	Going rate for occupation code (set at median using 2023 salary data)

- Salary must meet **both** requirements
 - General salary threshold applies regardless of working hours
- Going rate is pro-rated based on weekly working hours stated on certificate of sponsorship (divide annual going rate by 37.5 and multiply by weekly working hours)
- Minimum hourly rate has increased from £10.75 to £15.88 but this is now built into the going rates no longer a separate requirement

First-time applicants: job is on Immigration Salary List (option D)



Reduced salary threshold	£30,960 per year
Going rate	Going rate for occupation code (no reduction)

- Immigration Salary List replaces Shortage Occupation List
 - Only 23 occupations on the new list, including:
 - 2142 Graphic and multimedia designers
 - 3416 Arts officers, producers and directors
 - Multiple construction occupation codes

First-time applicants: applicant is a new entrant (option E)



Reduced salary threshold	£30,960 per year
Reduced going rate	70% of going rate for occupation code

- New entrant: under 26 or most recent visa was Student or Graduate or working towards a professional qualification in a regulated profession
- Maximum 4 years including any time spent on Graduate route to extend visa beyond that period they must be paid full going rate



New rules:

pre-4 April 2024 Skiller

Worker visa holders

Pre-4 April 2024 Skilled Worker visa holders: standard scenario (option F)



Reduced salary threshold	£29,000 per year
Going rate	Going rate for occupation code (set at 25th percentile using 2023 salary data)

- Pre-4 April 2024 Skilled Worker visa holders are only affected when making a new Skilled Worker application or applying for indefinite leave to remain
- See tables setting out conversion from SOC 2010 to SOC 2020 occupation codes

Pre-4 April 2024 Skilled Worker visa holders: job is on Immigration Salary List (option I)



Reduced salary threshold	£23,200 per year
Reduced going rate	80% of going rate for occupation code (set at 25th percentile using 2023 salary data)

This option also applies if the applicant's job has been removed from the Immigration Salary List / Shortage Occupation List and they are being sponsored to continue in the same job for the same sponsor

Pre-4 April 2024 Skilled Worker visa holders: applicant is a new entrant (option J)



Reduced salary threshold	£23,200 per year
Reduced going rate	70% of going rate for occupation code (set at 25th percentile using 2023 salary data)

Action points



- 4 April 2024. If current candidates will not meet the increased salary thresholds try to apply (or at least assign CoS) before 4 April
- Graduate recruitment . Bear in mind £30,960 minimum for new entrants and significantly higher going rate for some occupation codes and 4-year maximum
- Occupation codes. Choice of occupation codes will be more important have detailed job descriptions and think carefully about the appropriate code
- Consistent policy. Be careful about raising pay on a one -off basis to meet salary thresholds. In many cases it will not be possible to sponsor people for lower paid roles which can currently be sponsored plan for this and don't raise expectations of sponsorship. Seek employment law advice if needed.



Family visas

Family visas: increase in minimum income requirement



- Family visas: partner/ spouse and children of British citizens/ people with indefinite leave to remain
- Minimum income requirement increasing from £18,600 per year to:
 - £29,000 per year from 11 April 2024 (if relying on cash savings minimum will be £88,500)
 - £34,500 per year date unknown
 - £38,700 per year by early 2025
- Child element of minimum income requirement abolished
- New rules will not apply to people who already have a partner/spouse visa or who apply before 11 April 2024
- What will the next government do?
